Notes from Public Hearing Re: Bylaws 2 & 3 of 2013-Amendment to Basic Planning Statement Schedule "A" to Bylaw No. 01/2002 and amendments to Zoning Bylaw 01/2002 Appendix "B".

Present: (via phone) William Langen and Michael Scharfstein of Stevenson Hood Thornton Beaubier on behalf of Eric and Teresa Knogler.

Ardel and Gail Henderson in person

Mayor Quinn asked if Langen and Scharfstein were prepared to proceed with the hearing today. They confirmed they were.

<u>Langen</u> asked whether Council has had a chance to review their correspondence and confirmed they were acting on behalf of the Knoglers.

<u>Langen</u>: According to the Planning and Development Act, the RVCL is obligated to come up with and follow their Planning Statement.

<u>Langen:</u> the Knoglers are concerned about the amendment being a direct violation of the Planning and Development Act.

<u>Langen</u>: 9.2.5 & 6 (— unless outlined in a bylaw the waterfront is for public recreation and community service land only.

Langen: 11.24 - maintains that the RVCL must retain existing crown land

<u>Langen</u>: 11.3.4 – RVCL to discourage the transfer of crown land to one person for personal use. The rezoning will be a residential development on shoreline, which is a direct breach of the Basic Planning Statement.

<u>Langen</u>: They outlined all their concerns in their letter dated June 13, 2013. They want to reiterate that the Court judgment between Ardel Henderson and the Knoglers was not mandatory for a subdivision to be made. The court provides that if a subdivision was not done, they could renegotiate another option with Henderson.

Mayor Quinn: Asked if Council had any questions.

Langen wishes to remain on the line for the remainder of the hearing.

<u>Ardel Henderson</u> addressed Council and asked if they had any questions of him regarding the subdivision.

Councilor Tarasiuk asked to clarify what is crown land what wasn't.

<u>Henderson:</u> Purchased the property in 1997 from the Crown to make a subdivision. He was to keep one parcel and sell another if it could be divided. If it was not able to be divided then no sale would have taken place.

Mayor Quinn: Asked if anyone present would like to speak.

Etta Sackney: Would like clarification on if the property was at Barnes Place and if changing the planning statement by changing the shoreline to within 300 feet would affect other subdivisions.

<u>Mayor Quinn</u>: Yes the property is in Barnes Place and other subdivisions aren't relevant to this matter.

Mayor Quinn: Adjourns Public Hearing.
